No. 996] (collectively, the "Objections") to the Joint Motion for Entry of Second Amended Order Appointing Receiver (the "Motion to Amend Order") [Dkt. No. 958].

The Bankruptcy Movants are joining in the Objections to ensure that the record is clear that they object to any amended Receivership Order that contains the same (or substantially the same) injunction that is the subject of the Bankruptcy Injunction Motion, and which is the subject of a hearing scheduled for February 11, 2010. The Bankruptcy Movants object to the Motion to Amend Order for all of the reasons stated in the Bankruptcy Injunction Motion [Dkt. 772] and Reply Brief in Further Support of the Bankruptcy Injunction Motion [Dkt. No. 836].

The Bankruptcy Movants also join in objecting to the Receiver's request to expand the scope of the injunction contained in the Receivership Order to prohibit defrauded investors from prosecuting third-party claims.
