MOTION OF DEFENDANTS BLANCA FERNANDEZ, STEVE SLEWITZKE, JULIAN "BRAD" BRADHAM, LOU SCHAUFELE, VIRGIL HARRIS, HARVEY SCHWARTZ, ERIC URENA, NANCY HUGGINS, AND NOLAN FARHY TO DISMISS AND TO COMPEL ARBITRATION

COME NOW, Blanca Fernandez, Steve Slewitzke, Julian "Brad" Bradham, Lou Schaufele, Virgil Harris, Harvey Schwartz, Eric Urena, Nancy Huggins, and Nolan Farhy (the "Nine Defendants"), through undersigned counsel, and move to dismiss the Receiver's Second Amended Complaint Against Former Stanford Employees (the "Complaint") dated December 18, 2009 pursuant to Federal Rules of Civil Procedure 12(b)(3) and (6).¹ The Receiver fails to state claims against the Nine Defendants upon which relief can be granted by this Court. Specifically, the claims asserted in the Complaint are subject to and fall under valid mandatory arbitration clauses, or are otherwise subject to arbitration per FINRA rules. Further, venue for the claims asserted is improper here where the parties have formally agreed to arbitrate the claims in a foreign venue.

¹ Movants reserve any and all other Rule 12(b) motions at this time. Issues relating to the merits (or lack thereof) of the Receiver's claims should be decided by arbitration.

WHEREFORE, the Nine Defendants respectfully request that this Court dismiss the claims against them as set forth in the Complaint, that the Receiver be compelled to arbitrate the aforementioned claims against the Nine Defendants in the appropriate venue, for an award of the Nine Defendants' attorneys' fees associated with this motion, and for all other relief that this Court deems just and proper.
